Whereas, GTS and Dealer desire to enter into this Agreement, and whereas, Dealer desires to purchase Wizards of the Coast product from GTS and GTS desires to sell Wizards of the Coast product to Dealer.

Now, therefore, it is hereby agreed that by signing this agreement, Dealer is attesting that Dealer agrees to be held to the definition of Dealer as defined below:

The following documentation **MUST** be submitted to GTS Distribution before WOTC product sales can begin to your retail storefront(s).

1. Two pictures of retail storefront. Pictures should clearly show the following:
 - a. Outside signage - including front door and windows matching the name and address of store on account application
 - b. Indoor retail space - including WOTC product currently on display (if applicable) and gaming area if possible
2. Telephone directory page (Yellow or White) listing retail storefront's name, address and phone number. **OR**, a copy of the retail storefront's most recent utility bill listing retail storefront's name, service address, phone number and responsible party.
3. A signed WOTC Dealer Agreement

Digital pictures may be emailed directly to newaccounts@gtsdistribution.com; however emails (with picture attachments) must contain the Customer's Name and address of storefront. Failure to provide customer name and address will delay approval process. Customers who do not have access to digital cameras may send pictures to the address listed below.
